- Location:** Ogdensburg Free Academy Golden Dome, 1100 State Street, Ogdensburg, NY 13669
- Entry Fee:** \$20.00 per wrestler - Make checks payable to **Ogdensburg Youth Wrestling**
- Registration:** **ALL WRESTLERS MUST PRE-REGISTER**  
Registration Form, payment and copy of wrestler's birth certificate must be received by **March 12, 2008**

- Weigh-Ins:** **8 am - 9 am. Wrestling will start at 10 am.**  
Wrestlers **must be within 2 lbs of entered weight** or they will be disqualified from the tournament with NO REFUND.
- Brackets:** **6 Man Round Robin** - full brackets not guaranteed. One weight class and division per wrestler. No set weight classes - 12% rule will be in effect.  
**Tournament director reserves the right to combine or alter weight classes to promote optimum wrestling.**
- Divisions:** **D1: 6 - 7 years old** **D4: 12 - 13 years old**  
**D2: 8 - 9 years old** **D5: 14 - 15 years old**  
**D3: 10 - 11 years old** **D6: 16 - 18 years old\***  
**\*D6 Participants must still be in High School.**
- Rules:** **New York State Officials - All Decisions are FINAL**  
Unsportsmanlike conduct by a coach, wrestler or parent may result in disqualification of the wrestler(s) and removal from the tournament  
We reserve the right to remove anyone from the tournament without refund due to inappropriate behavior.  
**Divisions 1-4:** 1-1-1 minute periods  
**Divisions 5-6:** 1.5-1.5-1.5 minute periods  
**Overtime:** Sudden Death 1 minute period - No decisions 30 second ride out.
- Awards:** Wall plaques for 1st - 3rd. Participation medals for 4th - 6th places, D1 - D3 only.  
Team Trophies for top 3 teams. Enter 10 wrestlers. **No combining clubs or teams.**
- Admission Fee:** \$2.00 per adult, \$1.00 student, children under 5 free
